

## PLEA AGREEMENT

Jaggi Singh, a political activist and community organizer based in Montreal, is currently charged with three counts of conspiracy in relation to the G20 Summit in Toronto in June 2010. The Crown and Mr. Singh agree to resolve those charges in accordance with the following:

1. Mr. Singh will plead guilty to the offence of "counselling to commit mischief over \$5000" pursuant to section 464 (a) of the Criminal Code.
2. The Crown will withdraw the conspiracy charges against Mr. Singh and undertakes not to pursue any other charges against Mr. Singh related to the G20 Summit held in June, 2010 in Toronto.
3. The Crown agrees not to call Mr. Singh as a witness on the G20 prosecutions.
4. This plea agreement, including all attached exhibits, cannot be used by the Crown in any other legal proceeding.
5. Mr. Singh will offer no cooperation to the Crown or the police, nor will he offer any apologies for his actions.
6. The Agreed Statement of Facts attached as Exhibit A, Mr. Singh's twitter feed attached as Exhibit B, and the the dvd attached as Exhibit C will become part of the court record at the hearing of the charge of counselling to commit mischief.
7. The Crown and Mr. Singh agree to an open sentencing hearing on the understanding that the Crown will seek no more than 6 months in jail (less pre-trial custody) to be followed by 2 years of supervised probation with the following terms:
  - a. keep the peace and be of good behaviour;
  - b. appear before the court when required to do so by the court;
  - c. notify the court or the probation officer in advance of any change of name or address, and promptly notify the court or the probation officer of any change of employment or occupation;
  - d. report within 72 hours of your release from jail to a probation officer and be under their supervision;

e. complete 100 hours of community service work within the year of probation;

f. no direct contact nor direct or indirect communication with Joanna Adamiak, Patrick Cadorette, Leah Henderson, Amanda Hiscocks, Peter Hopperton, Alexander Hundert, Syed Hussan, Julia Kerr, Erik Lankin, Meghan Lankin, Adam Lewis, Terrence Luscombe, Monica Peters, David Prychitka, Paul Sauder, Sterling Stutz & William Vandriel.

8. Mr. Singh is not limited on his sentencing position and arguments.

9. The Crown and Mr. Singh agree to make sentencing arguments in front of Justice Bigelow of the Ontario Court of Justice.

10. The Crown agrees to take into consideration Mr. Singh's employment commitments, as well as preparation time for an open sentencing hearing, in scheduling the sentencing arguments in front of Justice Bigelow. In particular, there will be at least 4 weeks advance notice of the sentencing hearing, and the Crown agrees that any possible custodial penalty should be served no sooner than June 6, 2011.

11. This agreement will be entered, in writing, into the court record in both English and French and will not be subject to any publication ban.

12. This document along with the Agreed Statement of Facts (Exhibit A) as well as Mr. Singh's twitter feed from June 3 to July 6, 2010 (Exhibit B) and the June 24 Press Conference video (Exhibit C) constitutes the entirety of the agreement between Mr. Singh and the Crown.
